Lumin® Plywood: Pine and/or Eucalyptus Plywood for Structural Use in Internal Humid Conditions (EN 636 – 2 S)

Context of this Declaration

Regulation (EC) No 1907/2006 of the European Parliament and of the Council dated 18/12/2006 relates to the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH), and is enforced since 01/06/2007.

Uruply is fully aware of its responsibility as a manufacturer of Lumin[®] plywood products, which are "Articles" according REACH Regulation, and for which Uruply has to fulfil its duties and provide relevant information to its customers (named "downstream users").

Declaration of compliance to REACH Regulation

REACH Regulation does not intend a registration or pre-registration of any of the Uruply construction products, which are not chemicals. Uruply stays in regular contact with its suppliers which products may fall within the duty or registering or pre-registering the materials (chemicals) they produce and may be used as components of Lumin[®] plywood. The manufacturers of these materials, as well as the importers (where applicable) have insured Uruply that they do carry out the necessary registrations or pre-registrations where applicable.

Uruply can therefore confirm, as of today, that no restrictions have arisen for the production of Lumin[®] plywood in relation with REACH Regulation.

Information relative to Substances of Very High Concern (SVHC)

REACH Regulation intends a special licensing procedure for Substances of Very High Concern (SVCHC). Pursuant to article 33 of the Regulation, the supplier of a product which contains material listed by the European Chemicals Agency (ECHA) in the Candidate's List (<u>https://echa.europa.eu/web/guest/candidate-list-table</u>) in a concentration of more than 0.1% is obliged to inform its customer accordingly.

Uruply hereby confirms that none of the materials from the SVHC's Candidate List (status 13/12/2021) are used in the production of abovementioned products in a concentration exceeding 0.1%.
